Education, Advocacy, & Rehabilitation

Nearly ONE THOUSAND juveniles are on probation in Hennepin County. Over 70% of those young people are Black. Rebound, Inc. ("Rebound") is a grass roots, community-based non-profit dedicated to combatting the overrepresentation of African American youth in the juvenile justice system by leading the way in the innovation and provision of holistic, community centered, education, advocacy, and rehabilitation solutions at every phase of justice system involvement. Our initial programmatic efforts focus on re-entry after correctional placement.

ONE HUNDRED PERCENT of the young people who are incarcerated will return to our community someday. Even under the best circumstances, when correctional programs have endowed them with new skills and a plan to use them, they return to impoverished households, under resourced schools and negative peer groups. Rebound's "Jordan house" seeks to step into the gap and build a bridge to success for young men by providing a residential group home setting where they can receive culturally-specific individual and family therapy, and life skills services designed to help them develop positive connections to their families and communities.

During the 2016-2017 fiscal year, we were overwhelmed by an outpouring of support for Rebound, Inc. and Jordan House. It is because of partnerships with community members and youth-serving organizations that we were able to provide a transformative experience to the young men in our care, and to end the year in a strong financial position.

Beginning in January 2018, Rebound, Inc. will build on the success of Jordan House by expanding services to young women through Naima House. As we undertake this much needed work, we thank all of our donors and partners for their continued support.

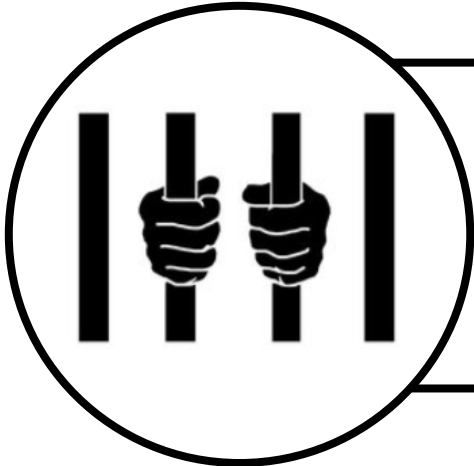

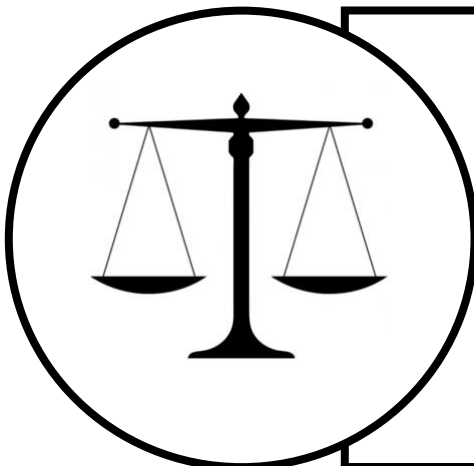
Juvenile Arrest

- 21,407 youth arrested in 2016
- African American Youth 4 times as likely as White Youth to be arrested



Out of Home Placement (OHP)

- 852 OHPs in the State in 2015
- 434 OHPs in Hennepin County in 2017
- 284 OHP of African American Youth in Hennepin County in 2017



Needs

- 67% suffer from symptoms of aggression, depression or anxiety
- 46% have a substance abuse disorder
- 36% have learning disabilities
- 13% have developmental disabilities,
- 38.1% of African American youth in Hennepin County reoffend
